Tito has over 40 years of experience as a lawyer.

Tito was a partner at Vasconcelos, F. Sá Carneiro, Fontes e Associados, between 1994 and 2004, and a partner at Uría Menéndez from 2004 until the end of 2022. Tito was the head of the Litigation Practice Area until the end of 2018 covering all aspects of dispute resolution in both contentious and non-contentious matters.

He represents clients in civil, criminal and commercial proceedings, at all instances including the higher courts and the Constitutional Court.

Tito has vast professional experience from more than 1000 cases in various national and international jurisdictions such as corporate litigation (including between shareholders), litigation on urban planning and real estate projects, litigation on contracts of a varied nature in multiple sectors, financial litigation (among others, regarding swaps) and inheritance litigation.

He also acts in arbitration hearings, either as an arbitrator or as a lawyer representing parties in insolvency proceedings.

Additionally Tito was a lecturer in several of the post graduate courses in arbitration at the Law Faculty of the "Universidade Nova de Lisboa" and at the Law Faculty of the "Universidade de Lisboa (Clássica)".

Tito has published several legal articles, particularly on arbitration topics.
